TERMS AND CONDITIONS- (i) International Cam Model Day 2025; (ii) Top Model Academy for German and Romanian (male) models and (iii) New Member Bonus.

Article 1- International Cam Model Day 2025

1.1.  \circ Achieve at least a minimum of 10 Members who spend money on the Model more than once.

• Achieve at least a minimum of 50 Members who spend money on the TMA Model's Interactive Toy.

(g) In each phase, you must meet the corresponding cumulative conditions to earn the respective Fixed Income.

(h) Taxes: Each TMA Model shall be responsible for paying their own taxes in accordance with the applicable regulations of their country of residence.

(i) Payment Fixed Income shall be subject to the terms of the normal payouts scheme provided in the Master Service Agreement.

(j) The Fixed Income will be paid as a bonus on top of the Period earnings.

Article 6- New Member Bonus

6.1 Eligibility:

- 6.1.1 Participation in this New Member Bonus constitutes acceptance of these specific terms and conditions and all other applicable rules and policies of the Website.
